What do I need to know to take this class?

These courses will help equip leaders to operate, innovate, and self-educate from a technical, data governance, and business standpoint. We will prepare you not just for the GenAI revolution but for the next several revolutions as well, so as to boost your business and career as well as protect your users.

Program overview

Upon completion of this 10-week course, you will be able to:

- Build a solid data governance framework to help identify and manage business risk with buy-in from key cross-functional partners.
- Develop tooling and processes for data protection to help drive regulatory compliance in the absence of set global standards and prescriptive laws.
- Enable review and consulting processes to identify risks inherent to data in how it is collected, processed, and shared.
- Measure the maturity of your organization's overall data-handling processes.
- Build a dynamic and evolving data strategy to adapt to limitations in training data, bias, hallucinations, data leakage, copyright issues, privacy regulations, insider risk, cybersecurity/phishing attacks, data poisoning, etc.
- Communicate at the right levels with different organizational layers ranging from IC to C-Level and from the whiteboard to the board level.

This program offers two, 5-week courses. You may take one or both courses. However, we strongly encourage you to review Course 1 before attending Course 2.
